The Oregon Organic Coalition is a 501(c)(6) volunteer run organization that relies on members financial support to promote and advocate for Oregon’s organic trade industry. ### Membership Dues:

Members pay annual dues, on a sliding fee scale (based on annual sales for businesses).

<b>\$50</b> --up to \$99,999	<b>\$250</b> --\$500,000-\$2,999,999	<b>\$1000</b> --\$20,000,000-\$49,999,999
<b>\$150</b> – \$100,000-\$499,999	<b>\$500</b> --\$3,000,000-\$19,999,999	<b>\$1500</b> –over \$50,000,000
